This privacy policy is complementary to, and should be read and understood together with, the general terms and conditions of use set out in Section A above.

1. The General Principles of our Privacy Policy

- 1.1. This privacy policy covers how we treat your personal information collected electronically when you use this site, register or apply online for any attooh! Financial Wellness (Pty) Ltd products or services, or when you contact attooh! Financial Wellness (Pty) Ltd electronically.
- 1.2. attooh! Financial Wellness (Pty) Ltd respects your privacy and your personal information and for this reason, we take care to protect your personal information and to keep it confidential.
- 1.3. When dealing with your personal information we apply the following:

You may revoke this consent in writing at any time.
